

## **PRIVACY POLICY**

The Personal Data Protection Notice ("the Notice") is issued pursuant to the enactment of the Personal Data Protection Act 2010 ("the Act") to regulate the collection and processing of your Personal Data (as herein defined) by **99 Speed Mart Retail Holdings Berhad**, its subsidiaries, associates, jointly controlled entities, affiliates (or referred to as "99", "99 Speedmart", "we" or "us") as the data controller of this website.

### **1. TYPE OF PERSONAL DATA COLLECTED**

2. National Registration Identity Card
3. Gender
4. Email address
5. Phone number
6. Payment information

**Purpose of collecting data may include but not limited to:**

1. Purchase of our products
2. Internal record and marketing
3. Legal compliance
4. Process payment and delivery
5. Customer care and support

#### **Cookies:**

When you visit any website, it may store or retrieve information on your browser, mostly in the form of cookies. This information might be about you, your preferences or your device and is mostly used to make the site work as you expect it to.

#### **Personal data provided by the data subject:**

When using this website's online facilities, data subjects may be required to provide their personal data for the purposes of Account Creation and Validation, and Marketing. All data will be kept strictly confidential, and the use of the information for any specific purpose(s) will require prior consent by data subjects.

5. Financial institutions for purposes of facilitating payments and/or maintaining financial records in connection with the business or contract relationship between 99 Speedmart and you and/or your company; and
6. Any other third parties 99 Speedmart may deem necessary and expedient.

You also have the right to request the blocking or erasure of data that has been processed unlawfully.
